NEW REQUEST:

- Karen Guthrie requested to use the tennis court Monday only from June 15, 2009 to August 31, 2009 from 9:00 – 10:30 am. Peggy Corbet motioned and Tim Brewer seconded to approve. Passed.
- CFYFL Pee Wee League (4<sup>th</sup> & 5<sup>th</sup> graders) requested to use football field Tuesdays, Wednesdays and Thursdays from July 28, 2009 to November 5, 2009 from 6:00 to 8:00 pm. Tim Brewer motioned and Jamie seconded with the following stipulations: *a) need insurance b) need release and hold harmless filled out by all participants and c) this is for Practice Only.* Motion approved and passed.
- Cynthia Granados requested to use one basketball court every Monday from June 29, 2009 to August 2, 2009 from 6:30 to 7:30 pm. At this time committee disapproved use due to high demand from residents who use the courts. ***HOWEVER if Ms. Granados is willing move her date and time to the following Friday's with the time frame of 6:00pm to 7:00pm OR any weekday/weekend before 5:00 pm, provide insurance and release and hold harmless this committee will change their vote motioned by Tim Brewer and seconded by Peggy Corbet to approved and passed.***

NEW BUSINESS: February 2008 the Recreation Committee and the Board of WLCA started charging for the use of the Facilities by Leagues, Coaches, Instructors and Clinics with the clear understanding we would re-evaluate the fees after 1 year. We are looking at raising all fees by 50% please see following rates changes:

- a. Soccer Fields -\$5.00 per hour/per team
- b. Baseball Fields - \$5.00 per hour/per team
- c. Basketball/Handball Courts - \$5.00 per hour
- d. Tennis - \$10.00 per person/per season
- e. Other - \$5.00 per hour/per team

NEW: Leagues

- a. Soccer Fields -\$7.50 per hour/per team
- b. Baseball Fields - \$7.50 per hour/per team
- c. Basketball/Handball Courts - \$7.50 per hour
- d. Tennis - \$15.00 per person/per season
- e. Other - \$7.50 per hour/per team

OLD: Instructors and Coaches

- a. Soccer Fields -\$5.00 per hour
- b. Baseball Fields - \$5.00 per hour
- c. Basketball/Handball Courts - \$5.00 per hour
- d. Tennis - \$6.00 per hour/per court
- e. Other - \$5.00 per hour

NEW: ~~Leagues~~ Instructors & Coaches

- a. Soccer Fields -\$7.50 per hour
- b. Baseball Fields - \$7.50 per hour
- f. Basketball/Handball Courts - \$7.50 per hour
- g. Tennis - \$9.00 per hour/per court
- h. Other - \$7.50 per hour

Tim Brewer motioned and Peggy Corbet seconded to vote on these rate changes at the next Rec meeting next month August 19, 2009. This will be a part of the Rec Committee report at the meeting July 27, 2009 held for the WLCA Board. Final approval for WLCA board to vote on at August 2009 meeting.
